<p>On Sunday, July 27th, 2025, Deputy State Fire Marshal Jordan VanBerkum was contacted by email from North Dakota State Fire Marshal Doug Nelson regarding a fire that occurred on July 26th, 2025. The fire was reported to be at 1020 68th St. SE, Hazelton, ND.</p> <p>This report was to document the fire occurrence. No response from the North Dakota State Fire Marshal's Office was requested.</p>

Remarks:
<p>Sheriff's Deputy Chris Vargas with the Emmons County Sheriff's Office contacted the North Dakota State Fire Marshal's Office regarding a fire that occurred at a vacant mobile home.</p> <p>The fire had self-extinguished before it was discovered by Sheriff's Deputy Vargas and was contained to the footprint of the mobile home and was a complete loss. It was unclear when the fire occurred, as there were no witnesses to when it started or ended.</p> <p>No further assistance was requested from the Emmons County Sheriff's Office.</p>
