



Reason For Supplemental Report:

On January 29^{th,} 2025, at approximately 3:30 PM, I Deputy State Fire Marshal Nick Fettig received a phone call from On-call State Fire Marshal to call Detective Lance Kitzan, Cass County Sheriff's Office about a structure fire. I contacted Detective Lance Kitzan about the incident via telephone. Detective Lance Kitzan stated a fire occurred in a large outbuilding at 2364 134th Ave Se, Tower City, ND.

Remarks:

Detective Lance Kitzan stated the Page Fire Protection District was dispatched to a fire at 2:35 PM on January 29th, 2025, for an outbuilding fire. Detective Lance Kitzan stated that the on-scene deputy spoke with the Fire Chief, and occupants of the structure and the following information was discovered. Kevin Baasch stated Kevin Baasch started a snowmobile then observed a fire under the snowmobile and the fire started to spread. Kevin Baasch called 911 about the fire and the Page Fire Protection District responded and extinguished the fire. Kevin Baasch stated Kevin Baasch had insurance through Nodak Mutal Insurance.

No assistance from the North Dakota State Fire Marshal's Office was being requested at this time.
