| I, Kirstin Greaney-Stanger, Deputy State Fire Marshal was contacted by Deputy State Fire Marshal Jordan VanBerkum about a fire that occurred at 725 Park Lane, Milnor, ND on Sunday, February 9, 2025. This report was to document the fire occurrence. No response from the North Dakota State Fire Marshal's Office was requested. |

| <p>I contacted Milnor Fire Department Fire Chief Mike Elenberger. Mike Elenberger stated the Milnor Fire Department was paged out on Sunday, February 9, 2025, at approximately 3:30 PM. Mike Elenberger stated on the fire department's arrival the residence was full of smoke and flames were seen in the ceiling and underside of the trailer home. Mike Elenberger stated the trailer home also had flames in the laundry room and furnace room.</p> <p>Mike Elenberger stated the trailer home was occupied at the time of the fire by one of the residents Maria Agular with an infant child. Mike Elenberger stated there were no injuries or fatalities sustained in the fire. Mike Elenberger stated Maria Agular had reported seeing smoke out of the floor vent in the kitchen before evaluating from the residence.</p> <p>Mike Elenberger stated the fire is not believed to have been started intentionally. Mike Elenberger stated they were not sure if a space heater or heat tape was used on the pipe under the trailer home at the time of the fire to keep the piping from freezing. Mike Elenberger stated due to the sever cold they were not able to access the area of origin to determine. Mike Elenberger stated the trailer home would be torn down as soon as the temperatures warm up. Mike Elenberger stated a plumber had come out to the residence to assist because a water pipe had ruptured after the fire.</p> <p>Fire Chief Mike Elenberger stated they were not requesting assistance, they just wanted to pass the information along.</p> |
