





Reason For Supplemental Report:

On Thursday, February 27, 2025, at approximately 2:40 pm, I Deputy State Fire Marshal received a phone call from Fire Chief Benjamin Tucker of the St Thomas Fire Department regarding a fire that occurred at 107 Main Street, St Thomas, ND. No response from the North Dakota State Fire Marshal's Office was requested.

Remarks:

Fire Chief Tucker stated that Fire Chief Tucker received a phone call regarding a fire that occurred at approximately 7:00 am at 107 Main Street, St Thomas, ND. The property was owned by Scott and Sandy Berg.

Fire Chief Tucker stated the occupants awoken to smoke in their garage and observed a small plastic trash can next to an exterior garage wall was on fire. The damage was contained to the plastic trash can and the exterior wall above the plastic trash can. Fire Chief Tucker provided me photographs that showed a v-pattern on the wall where the plastic trash can was within the garage. The photographs will remain with the file.

Fire Chief Tucker stated the cause of the fire was from discarding of smoking materials from an ash tray into the garage.

No other assistance from the North Dakota State Fire Marshal's Office was being requested at this time.
