Reason For Supplemental Report:
<p>On September 17, 2025, I, Deputy State Fire Marshal (DSFM) Jess Sinerius, was contacted by Fire Chief Jason Keen of the Donnybrook Fire Protection District regarding a wildfire.</p> <p>No response was requested from the ND State Fire Marshal's Office. It was noted that if new information becomes available or circumstances change, our office should be contacted.</p>

Remarks:
<p>Fire Chief Jason Keen stated that on Wednesday September 17, 2025, at approximately 3:00 PM the Donnybrook Fire Protection District was dispatched to a grass/field fire off Highway 5.</p> <p>Fire Chief Jason Keen stated that a pickup truck and cattle trailer had turned off Highway 5 onto a prairie trail when the vegetation under the truck caught fire. The truck operator drove the truck and trailer to a nearby dirt road and called 911. The truck and trailer were not impacted by the fire.</p> <p>The fire department arrived on scene and extinguished the fire without incident. Fire Chief Jason Keen wanted to report the fire to the State Fire Marshal's Office.</p>
